

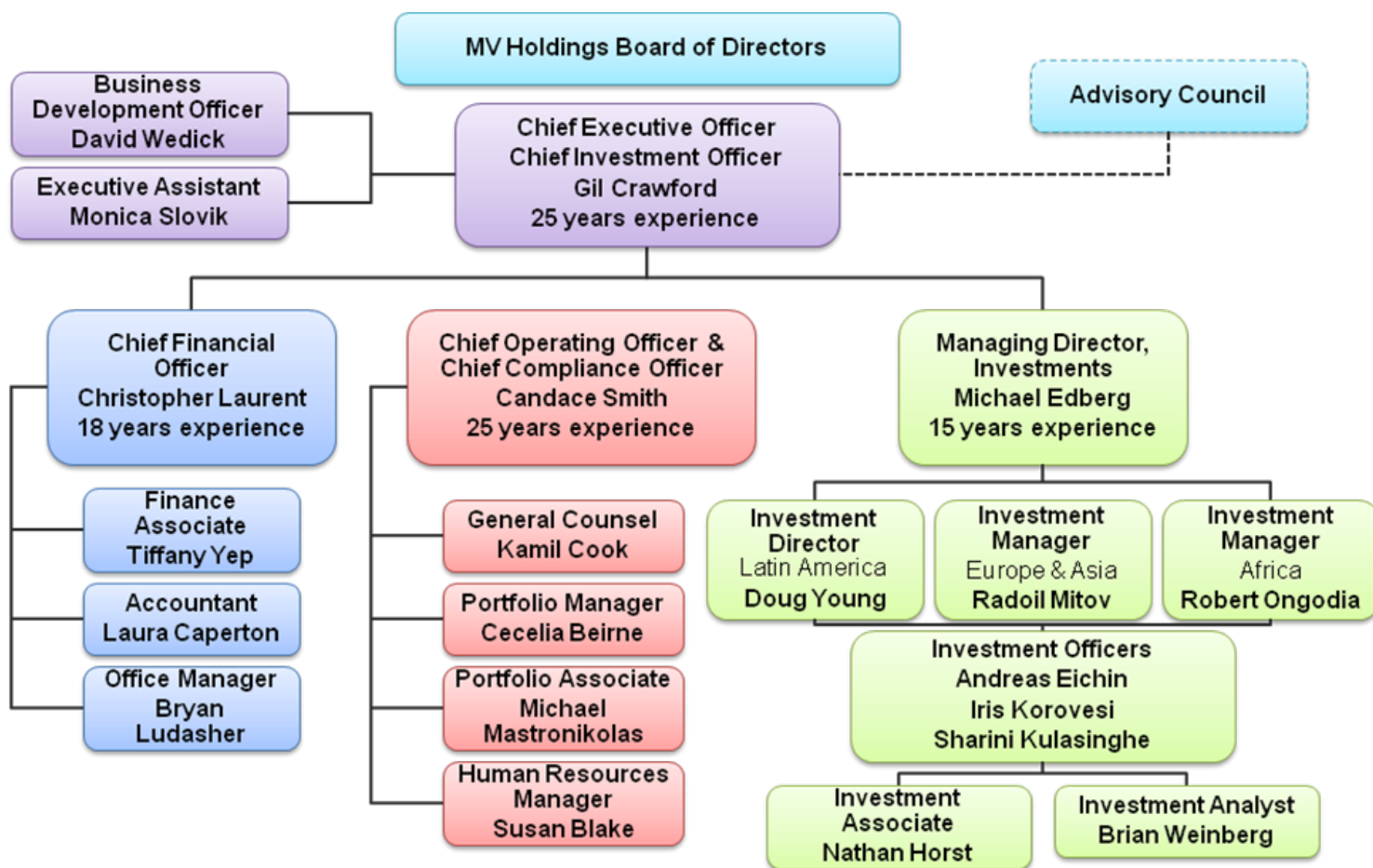
MicroVest Announces Executive Promotions
